



CONDITIONS AND PROCEDURE FOR ADMISSION

1. The criteria to be met by organizations wishing to apply for membership of the WVF are set out in Article 5 of the Constitution and Rule 2 of the Constitutional Rules (*copy attached*).
2. Organizations wishing to be admitted into the WVF must submit a request to that effect to the WVF Secretary General by completing the membership application form (*both attached*).
3. Membership of the WVF shall be conferred by the General Assembly on presentation of the application by the Executive Board (Article 7 of the Constitution).
4. Successful Member Associations would be obliged to pay annual dues as provided for in Article 7 of the Constitution. The *Membership Dues Guide* (copy attached) sets out in paragraphs 3 and 4 the provisions applicable to newly admitted Associations.

WORLD VETERANS FEDERATION NEW MEMBERSHIP SCALE FROM 2020

Honorary Lifetime Member of the WVF



Ordinary and Associated Members of the WVF can become an Honorary Lifetime Member and member of the Board of the Honorary Members Club of the WVF for a total fee of **50 000 Euro**. (Members of the Honorary Members Club will also be on an advisory board for the WVF with a yearly meeting)

Honorary Member of the WVF



Ordinary and Associated Members of the WVF can become an Honorary member and member of the Honorary Members Club for a **5 000 Euro** yearly fee. (Members of the Honorary Members Club will also be an advisory board for the WVF with a yearly meeting)

Ordinary Member (every member organization)



Ordinary Members shall pay a yearly fee of **1 800 Euro**. This should be paid by 1st of January of the year in question at the latest. If they fail to pay this later than 1 month after the due date they will be reduced to Associate Member.

Associate Member (nonpaying members)



This category is open to new applicants who are not able to contribute financially to the Federation. Other members who have outstanding membership dues will also see their status reduced to Associated Member, with membership rights revoked, until their outstanding membership dues are up to date. Associate Members have no voting rights and can participate at WVF meetings as observers for a set fee.
